# **IMPORTANT NOTES TO EXHIBITORS**

**CERTIFICATION:** A certification completed in accordance with Chapter 3, Section 2 of AKC Tracking Regulations must be submitted with entry form for a dog that has not passed an AKC TD or TDU Tracking Test.

**TEST LIMIT & RANDOM DRAW**: This test is limited to 4TD/4TDX dogs. If the limit for entries is not reached in one test and the limit for entries is exceeded in the other test, the number of tracks will be exchanged on a basis of 2 TDs for 1 TDX. Entries will remain open until 5 P.M., TUESDAY, November 26, 2019. If entries received exceed the test limit of 4 TD and 4 TDX dogs, a public drawing will be held TUESDAY, November 26, 2019, at 6:30 PM, Starbucks, 815 East 17<sup>th</sup> St, Longmont, CO (corner of 17<sup>th</sup> and Pace). Any interested parties may attend. *Preference for the first TD and TDX tracks drawn will be given to Buckhorn Valley Kennel Club test workers from the 2017 TD/TDX, 2018 VST tests.* Acknowledgment will be e-mailed to all entrants as soon as practicable. When the advertised entry has been reached, any additional entries will be similarly drawn and placed on the alternate list. In all cases, preference will be given to dogs that have not yet earned the TD/TDX title.

**ENTRY FEE**: TD-\$65.00/TDX-\$110.00. (The entry fee includes .50 AKC recording fee and \$3.00 AKC Event service fee.)

**USE THE OFFICIAL AMERICAN KENNEL CLUB ENTRY FORM** and write "TD" or "TDX" in the "Obedience Trial Class" space. Telegraphed, telephoned, unsigned, conditional or incomplete entries cannot be accepted. Entries not on an official AKC entry form and photocopies of forms without the Agreement and Rules on the reverse side of the official AKC entry form are not acceptable.

**THE ORDER OF RUNNING** will be determined by a draw for tracks at the time called for on the face of this premium list.
